The Contracted Services Committee of the Township has recommended an appropriation of \$50,000.00 to Lakeshore Advantage to advance business development.

Next were various Ottawa County Road Commission project estimates for street maintenance and improvements. The estimates include 5.94 miles of various subdivision streets for \$1,587,857.70. The Board also reviewed two maintenance project estimates from the Ottawa County Road Commission. The first was for chloride application for dust control on various streets. The estimated cost is \$1,680.00. The Board also considered a project estimate with the Ottawa County Road Commission for roadside mowing and trimming on portions of US-31 & BL-196 at a cost of \$8,925.00 for one cycle of mowing and trimming.
