SUBJECT: 2026 Street Resurfacing and Maintenance Strategy

Similar to past years, staff has assembled a proposed subdivision resurfacing program for 2026. This proposal is based on a field review of road segments provided by the Ottawa County Road Commission (OCRC). The OCRC compiles their list of roadways to consider based on surface condition ratings using the PASER system. There were thirty-five subdivision street segments considered this year. No local roads were proposed this year.

Township staff reviewed the list and conducted a field review of the segments that a.) Had a PASER rating of three (3) and/or b.) Had been recommended for resurfacing previously but were not selected due various factors (funding, upcoming utility project, etc.). Based on these evaluations, thirteen subdivision street segments are being recommended for resurfacing. These are highlighted yellow on the attached roadway list and shown on the attached map

The estimated cost to resurface the recommended segments is \$759,338. Costs for mowing and dust control are still being developed and will be added to this total. The amount budgeted for road resurfacing and maintenance is \$1.0M.

If the Board finds the proposed program acceptable, staff will bring the formal project estimates to the February 19 meeting for consideration.


Cold milling of top surface layer; bituminous resurface of existing pavements;
