Mail theft is on the rise, and residents of Ottawa County are being urged to take precautions. Criminals often target mailboxes to steal personal information, checks, and packages. The Ottawa County Sheriff's Office shares the following tips to help keep your mail secure:

- 1. Pick Up Your Mail Promptly: Don't leave mail in your box for extended periods. Try to collect it daily, especially during peak hours.
- 2. Never mail cash.
- 3. Any financial mail should be dropped off at the post office.
- 4. Use a Locked Mailbox.
- 5. Shred Sensitive Documents: Shred any mail containing personal or financial information before discarding it.

By staying vigilant and following these steps, you can reduce the risk of mail theft and protect your personal information. Stay safe, Ottawa County!








