

The following Zoning Amendment Ordinance was adopted at the Holland Charter Township Board meeting held on September 19, 2019.

ORDINANCE NO. 600

ZONING MAP AMENDMENT ORDINANCE

AN ORDINANCE to amend certain portions of the Zoning Ordinance and Map of Holland Charter Township, Ottawa County, Michigan, for the purpose of adding certain lands to the I-1 Light Industrial zoning district.

THE CHARTER TOWNSHIP OF HOLLAND, COUNTY OF OTTAWA, AND STATE OF MICHIGAN, ORDAINS:

Section 1. Rezoning to I-1 Light Industrial District.

That the Zoning Ordinance and Map of the Charter Township of Holland, Ottawa County, Michigan, said map being incorporated by reference in the Zoning Ordinance for the Charter Township of Holland pursuant to Section 2.2 thereof, be and the same is hereby amended, changed and altered so that hereafter the lands hereinafter described shall be zoned as and included in the I-1 Light Industrial zoning district on said Zoning Map. Said lands are described as being in the Charter Township of Holland, Ottawa County, Michigan, described as follows:

Part of the Southeast 1/4 of Section 4, Town 5 North, Range 15 West, Holland Township, Ottawa County, Michigan, described as: Beginning at the South 1/4 corner of said Section; thence N00°05'09"E 961.46 feet along the North-South 1/4 line of said Section; thence N89°14'09"E 323.13 feet, parallel with the South line of said Section; thence S00°05'09"W 520.00 feet; thence S45°00'00"W 37.00 feet; thence N89°54'51"W 62.00 feet; thence S00°05'09"W 416.57 feet; thence S89°14'09"W 235.00 feet along said South line to the Point of Beginning. Contains 6.35 acres. Subject to easements, restrictions and rights-of-way of record. Also subject to highway right-of-way for Quincy Street over the most Southerly 33.00 feet thereof.

Said lands are addressed as 12345 Quincy Street, described more specifically as Parcel Number 70-16-04-400-023.

Section 2. Effective Date.

That the foregoing amendment to the Holland Charter Township Zoning Ordinance and Zoning Map was approved and adopted by the Township Board of Holland Charter Township, Ottawa County, Michigan, on September 19, 2019 after initiation and a public hearing by the Planning Commission on August 6, 2019, as required pursuant to the Michigan Act 110 of 2006, as amended, and after introduction and a first reading by the Township Board on September 5, 2019, and publication after such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on October 4, 2019 which date is more than 7 days after publication of the ordinance as is required by Section 401(6) of Act 110 of 2006, as amended, provided that this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110 of 2006, as amended.
