

*The following Zoning Amendment Ordinance was adopted at the Holland Charter Township Board meeting held on August 1, 2019*

ORDINANCE NO. 595

**ZONING MAP AMENDMENT ORDINANCE**

AN ORDINANCE to amend certain portions of the Zoning Ordinance and Map of Holland Charter Township, Ottawa County, Michigan, for the purpose of adding certain lands to the R-2A Medium Density Residential zoning district.

THE CHARTER TOWNSHIP OF HOLLAND, COUNTY OF OTTAWA, AND STATE OF MICHIGAN, ORDAINS:

**Section 1. Rezoning to R-2A Medium Density Residential District.**

That the Zoning Ordinance and Map of the Charter Township of Holland, Ottawa County, Michigan, said map being incorporated by reference in the Zoning Ordinance for the Charter Township of Holland pursuant to Section 2.2 thereof, be and the same is hereby amended, changed and altered so that hereafter the lands hereinafter described shall be zoned as and included in the R-2A Medium Density Residential zoning district on said Zoning Map. Said lands are described as being in the Charter Township of Holland, Ottawa County, Michigan, described as follows:

PART OF NW 1/4 COM 76.86 FT E OF W 1/4 COR, TH N 32D 30M 33S E 318.28 FT ALONG CENTER LINE BEELINE RD, TH S 64D 01M 39S E 164.62 FT, S 196.31 FT, TH W 319.05 FT TO BEG. SEC 16 T5N R15W FROM 16-16-100-019 4/90

Said lands are located at 12749 Felch Street, described more specifically as Parcel Number 70-16-16-100-063.

**Section 2. Effective Date.**

That the foregoing amendment to the Holland Charter Township Zoning Ordinance and Zoning Map was approved and adopted by the Township Board of Holland Charter Township, Ottawa County, Michigan, on August 1, 2019 after initiation and a public hearing by the Planning Commission on July 9, 2019, as required pursuant to the Michigan Act 110 of 2006, as amended, and after introduction and a first reading by the Township Board on July 18, 2019, and publication after

such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on August 16, 2019 which date is more than 7 days after publication of the ordinance as is required by Section 401(6) of Act 110 of 2006, as amended, provided that this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110 of 2006, as amended.
