

**HOLLAND CHARTER TOWNSHIP  
LICENSE APPLICATION FOR GOING OUT OF BUSINESS SALES,  
FIRE SALES, SMOKE, BANKRUPTCY, ETC...**

PUBLIC ACTS 39 of 1961, 219 of 1963 and 65 of 2007, as amended.

FEE: \$50.00 for the first 30 days; \$50.00 for each additional 30-day extension, up to two (2) 30-day extensions. License is to be issued for a 30-day period only.

On a separate piece of paper provide a written statement giving a full explanation with regard to the condition or necessity which is the occasion for the sale, including a statement of the descriptive name of the sale and the reasons why the name is truthfully descriptive of the sale. Also include a statement specific to the type of sale as follows:

Going-Out-Of-Business Sale: Applicant is to state that the business will be discontinued at the termination of the sale.

Removal Sale: Applicant is to state that the business will be discontinued at the termination of the sale, and the location of the premises to which the business is to be moved.

Fire, Smoke, Water Sale or Otherwise: Applicant is to state time and location of sale and cause of damage.

Applicant shall provide a full, detailed and complete inventory of the goods that are to be sold, which inventory shall:

1. Itemize the goods to be sold and contain sufficient information concerning each item, including make and brand name, if any, to clearly identify it.
2. List separately goods which were purchased during a 60-day period immediately prior to the date of making this application.
3. Show the cost of each item in the inventory together with the name and address of the seller of the items to the applicant, the date of the purchase, the date of the delivery of each item to the applicant and the total value of the inventory at cost.
4. In no case exceed 200% of the total value of merchandise upon which personal property tax was paid by the applicant or his predecessor as evidenced by a copy of the last personal property tax receipt issued.

Applicant shall provide a written statement that no goods will be added to the inventory after the application is made or during the sale and that the inventory contains no goods received on consignment.
